Network with your City Officials: Now is your chance to meet your city's elected officials and departments. After introductory remarks, you will be able to move around the room and talk to the city officials and their staff.

HOW NEIGHBORHOOD COUNCILS WORK - Room 1050

Presented by: Ivan Spiegel, Parliamentarian, Venice NC

There are many things that each NC Board member needs to know in order to be effective. On the surface, a neighborhood council is a government agency that holds public meetings. Because meetings are public, there are regulations for notifying your stakeholders as to what will happen at your meetings and how they can participate. You must be aware of the rules and procedures needed to make these meetings engaging and productive. Board Officers, each with a role to play, must learn to create an inviting environment so that stakeholders feel free to express themselves. There are financial reporting requirements that need to be followed in order to protect the taxpayer monies that you have been entrusted with allocating. At this session, you will also learn about the important roles that committees play in helping the Board reach decisions. On another level, there are best practices that councils should employ in order to attain the Holy Grail. At the core of it all, the neighborhood council is not a monthly meeting where people vote. You have joined a grass roots effort to make positive changes in both your community and the City of Angels.

PUBLIC SAFETY & EMERGENCY PREPAREDNESS - Room 1020

Presented by: Nina Royal, Treasurer & Safety Committee Chair, Sunland-Tujunga NC

Speakers: Larry Bogatz, Battalion 18 Coordinator, Los Angeles City Fire Dept.; Mark Seigel, Amateur Radio Volunteer Examiner, Sunland-Tujunga NC; Monica Marmon, LAPD Volunteer

This workshop has a dual focus. Most of the time will be devoted to emergency preparedness. However, you will also hear about Senior Lead Officers and Community Police Advisory Boards. In the emergency preparedness section, you'll learn how your neighborhood can take care of itself in a major emergency, such as a giant earthquake. Training and maintaining a local Community Emergency Response Team is one way neighborhood councils can help. This session will explain the CERT training, team maintenance and deployment process. It will also cover terrorist threats, profiling behavior, and how to take action. You will come away from this Workshop with a broad overview of many emergency preparedness programs and resources.

DEVELOPING LEADERSHIP SKILLS FOR BOARD MEMBERS - Room 1010

Presenter: Jill Banks Barad, Founder & Chair, Valley Alliance of Neighborhood Councils / President, Sherman Oaks NC

Panelist: Judith Daniels, Chatsworth NC

This workshop is designed for neighborhood council Presidents and Board members to acquire the know-how and confidence to conduct successful meetings and to motivate your Board to participate and work as a team.

Topics will include: The social skills necessary to be a leader; how to put together an agenda that will ensure transparency, attract the public and keep within time constraints; how to maintain control at meetings and still be fair.

The neighborhood council system is ten years old! To mark this important milestone, the Board of Neighborhood Commissioners has launched the Empower LA Awards to acknowledge those neighborhood councils who effectively carry out their basic mission to engage local stakeholders with government and to make government more accountable and responsive to the needs of communities. Come hear from this year's award winners about their successful efforts to reach out to and involve community members and to partner with City Departments to get things done in their neighborhoods.

CITY BUDGET: IS THE CITY HEADING TOWARDS INSOLVENCY - Room 1070

Presenter: Jack Humphreville, Greater Wilshire NC

Is the City of Los Angeles heading towards insolvency? The balanced budget is hardly balanced. The City has declared a State of Financial Emergency. There is a \$10 billion unfunded pension liability. Our lunar crater streets, the second worst in the country, our sidewalks and curbs, our parks and trees and the rest of our deteriorating infrastructure needs at least \$10 billion in repairs and maintenance. And the City is projecting a four year budget gap of over \$1.1 billion and that includes the very limited impact of the Mayor's so called pension reform plan that was announced on Wednesday.

We will discuss where we are today, how we got into this mess, and the prospects for the next few years. But the emphasis will be on solutions.

RESOURCES: TREASURER TRAINING FOR NEIGHBORHOOD COUNCILS - Room 350

Speaker: Betty Wong Oyama, EmpowerLA

You'll get an overview of how neighborhood council finances work. Treasurer Training is required for neighborhood council Treasurers and second-signatories. It is also recommended for all Board members, since the Board regularly reviews and approves financial statements and decides how to allocate funds. This session will satisfy the Treasurer Training requirement for newly elected Treasurers.

YOUTH ISSUES COMMUNITY INVOLVEMENT, PUBLIC SAFETY - Room1035

Moderator: Kevin Taylor, Reseda NC

Panelists: Bobby Arias, Joseph Collins, Beth Ryan

Growing up in an urban area poses special challenges. This is particularly true in lower income neighborhoods, where ethnic identities, the sense of 'turf', and fewer life options can lead the most vulnerable youth out of mainstream life and into gangs. Gang involvement can start as early as elementary school. The life prospects for young people who join gangs are bleak. This workshop will cover ways in which the city, the community, and young people themselves are working to assure that all youth have options. It will cover the city's Gang Reduction and Youth Development (GRYD) program, youth programs of the Los Angeles Police Department, collaboratives like the San Fernando Valley Coalition on Gangs, the Safe Routes to Schools program, the work of ministries and social service organizations, and programs in which young people themselves interact to provide peer counseling and support. Community involvement in programs that provide activities, mentoring and jobs is crucial. There are many opportunities for neighborhood councils to improve both youth opportunities and safety in the neighborhoods they serve.

WORKING WITH CITY COUNCIL COMMITTEES - Council Chambers

Presenter/Coordinator: Ankur Patel, Northridge NC; Jeff Ebenstein, Legislative Deputy; Councilman Paul Koretz

City Council committees are one way for you to have impact on legislation while it is being developed. This program will describe each committee, its current members, the subjects it handles, and key staff contacts. You will find out how to use the Early Notification System to get agendas by electronic mail. You will learn how to use the online Council File system to obtain documents relating to issues pending before the City Council, along with the history and current disposition of each Council File. Probably most important, you'll learn that battles are won or lost long before they get to the City Council floor. Ever wondered about all those 15-0 council votes? Committees are the answer.

COUNCIL FILES COMMUNITY IMPACT STATEMENTS GETTING HEARD - Room 1035

Presenter: Shannon Hoppes, Manager, Council and Public Services Division, Office of the City Clerk

This workshop is a practical tutorial on how to listen to the system, and how to get the system to listen to you. You will find out how to use the Early Notification System to get agendas by electronic mail. You will learn how to use the online Council File system to obtain documents relating to issues pending before the City Council. You will learn how to file a Community Impact Statement to place the official actions of your neighborhood council into the Council File. Perhaps most important, you'll learn that when your Board takes a position on an issue, that's only the beginning of your work. Your council needs to actively promote its position through email and telephone calls to officials, through your web site, and through personal appearances at City Council committees.

CHARMING THE CHALLENGING PERSON - Room 1050

Presenter: Emily Williams, Deputy Chief of Staff, Los Angeles City Councilmember Tony Cardenás

Challenging and difficult people are everywhere. Begin by understanding that their troublesome behavior is (in their opinion) a matter of survival and self-protection. Then remember that if difficult people can get you to 'lose it,' they have won. This workshop will help you to:

- · Identify strategies that will protect colleagues, the public, and the process from being usurped by the difficult person;
- · Learn ways to more effectively work with people who frequently display difficult behavior; and
- Familiarize yourself with coping mechanisms that you can use when conflict reaches a fever pitch.

ETHICS AND OPEN GOVERNMENT (State-Required Training) Session 1 of 2 - Room 350

Moderator: Darren Martinez, Managing Deputy City Attorney, Neighborhood Council Advice Division General Counsel Division

IMPORTANT: You must also take the second half (after lunch) of this session to complete your Ethics Training requirement.

Government Code section 53235 requires ethics training for local government officials, including neighborhood council Board members. You must take this training within the first year of gaining office and every two years after that. In order to get a certificate of completion, you MUST enroll in and complete both this program and the second part, which will be held during Session #3. Part 1 will show you examples of conflicts of interest under the Political Reform Act, explain how Common Law controls personal bias in decision-making, and cover Government Code Section 1090's prohibition of financial interests in public contracts.

PLANNING AND LAND USE 101 (What Land Use Committees Do; Planning Packets) - Room 1060

Moderator: Russell Brown, Downtown Los Angeles NC

Planning and Land Use committees are common to all neighborhood councils. The cases and other issues they bring to neighborhood council Boards are often matters of strong community interest. These matters also can be hard to understand without some basic knowledge. This program will give you that basic knowledge. It is intended to help Board members and stakeholders as well as new members of land use committees. You will get a general idea of how planning and zoning work, by-right versus discretionary development, conditional use permits, the hearing process and "findings", and the planning appeals process. The General Plan, Community Plans, Specific Plans, Historic Preservation Overlay Zones, sign districts, and some important State laws that affect the local planning process will be briefly described. You will learn how planning cases are numbered, and how to look up cases and properties on a wonderful online tool called ZIMAS. You'll also learn why it can be important to consider land use proposals BEFORE a case is filed, and why your council should care about issues like "code simplification" and "development reform". Finally, you will leave the program with numerous ways you can learn more and get help, including PlanCheckNC.

CONSOLIDATED PLAN SURVEY — INFLUENCE USE OF FEDERAL FUNDS IN YOUR COMMUNITY - Room 1070

Moderator: Ana Lynn Rocio, Senior Director, Community Development Policy and Porgrams, Office of the Mayor

The Consolidated Plan is the City's five year strategy to revitalize low income neighborhoods through community and economic development projects, affordable housing, and activities that address homelessness. Neighborhood councils will have an opportunity to learn more about the Consolidated Plan process and give their feedback on proposed City strategies.

ROLE OF THE CITY'S PORT AIRPORTS AND DWP IN TRADE AND BUSINESS - Room 1025

Moderator: Robert Gelfand, President LA Neighborhood Council Coalition

The core element is that international trade is expected to grow robustly during the next several years, including exports as well as imports. This is going to provide opportunities for local job creation and business development. The question we have been asking is this: How can we arrange for the most job and business development in the private sector based on international trade? One answer involves making Los Angeles more business-friendly, and this is something that neighborhood councils should definitely take up. Another answer involves negotiating with foreign trade organizations and their governmental representatives in order to maximize the number of us locals who will be hired or contracted to do value-added work on imports.

NEIGHBORHOOD COUNCIL ALLIANCES AND COLLABORATION - Room 1010

Moderator: Jill Banks Barad, Founder and Chair Valley Alliance of Neighborhood Councils

Panelists: Leonard Shaffer, LA Neighborhood Council Coalition; Doug Epperhart, Harbor Alliance of Neighborhood Councils

This workshop introduces the ways neighborhood councils are forming alliances to help each other and advocate as one voice. How did these alliances start and how do they function? What is their organizational structure? These include the regional alliances with similar communities of interest and LANCC. The Budget Advocates, NC/DWP MOU Oversight Committee and PlanCheck focus on specific City issues. And this year cooperation is being built through the City's 12 election regions. With deep staff cuts at DONE, the department is unable to provide a high level of training and support, so the councils are helping themselves through a peer network such as the Valley Alliance Resource Board which is a "go- to" place for guidance and mentoring. You will come away with a wide range of contacts and opportunities for organizing and being more effective within the neighborhood council system.

City services are delivered by city departments. Knowing which department does what is a critical first step to having an impact on service delivery to your neighborhood. This workshop will bring managers from some of the most important city departments to share their inside view of how to get results. Typical issues and online reporting systems for the most-contacted departments will be covered. Key contacts at departments will be revealed, especially where departments maintain a special liaison for neighborhood councils. In this workshop, the people who run the system will show you how to make the system work for you.

GREEN AND SUSTAINABLE LIVING - WHERE TO GO FOR HELP - Room 1020

Presenter: Carolyn Casavan, President, San Fernando Valley Green Team

Many neighborhood council board members and stakeholders are concerned with "green" issues. This program will present a wide-ranging survey of technologies, organizations, resources and activities that help us make a lighter footprint on the earth. The workshop won't explain any one area. It WILL give you a huge toolkit with which you can make your neighborhood a more earth-friendly place. Utility-related subjects include residential solar power, water conservation and dual meters, gray water systems, rain barrels, runoff capture, and gardening with native plants. Community beautification with plants will be viewed for the benefits of an urban forest, water conservation, and permeable hardscapes. Water-efficient landscaping laws and planning requirements will be referenced, as well as Green Building Standards and Low Impact Development rules. Fruit trees, vegetable gardens and composting are great for those with a place to grow. There is also a community garden movement to provide everyone with an opportunity to grow fresh food, herbs and flowers. Finally there is the sustainability movement and Green politics (dark green, light green and bright green!). Who knows how much of this the speakers will be able to cram in? It should be fun.

LOBBY LIKE A PRO: WHO AND HOW TO GET THINGS DONE? - Council Chambers

Moderator: Tony Wilkinson, Panorama City NC **Presenter**: Jay Beeber, Sherman Oaks NC

Everyone complains about the power and influence that lobbyists and special interests have at City Hall. Often, we hear the charge, "But the people don't have a lobbyist." However, ordinary citizens, especially those working within the Neighborhood Council system, can be as effective as the most seasoned lobbyist. This session will show how to lobby City Hall like the professionals do and how the voice of the people can be heard above the clatter of the influence peddlers.

HOW TO RUN A MEETING - Room 1050

Presenter: Ivan Spiegel, Parliamentarian, Venice NC

Running an effective meeting is an art, not a science. At the end, the group must have accomplished real work, participants must feel that they had an opportunity to be heard, and people should believe that the process was fair. That's a tall order for a meeting chair, especially if you have never managed a large public meeting. Nevertheless, these are essential skills, for committee chairs as well as for Board Presidents. Learn how to create a clear, descriptive agenda with time targets and ways of keeping your stakeholders aware of what the procedures are. Where does the Brown Act come into play and how does it help to insure the integrity of your meetings? Roberts Rules of Order is only one framework for fair meeting control, but there are other options that can sometimes be more effective, especially if you have to work with difficult people. Learn what role a parliamentarian can play to help plan and orchestrate a meeting. This session will give you tips and best practices on how to be a more effective leader, most of which you can't learn in a textbook.

ETHICS AND OPEN GOVERNMENT (State-Required Training) Part 2 of 2 - Room 350

Presenter: Darren Martinez, Managing Deputy City Attorney, Neighborhood Council Advice Division General Counsel Division

IMPORTANT: You must take the first half (before lunch) of this session to complete your Ethics Training requirement.

Government Code section 53235 requires ethics training for local government officials. In order to get a certificate of completion, you MUST enroll in and complete both this program and the first part, which will be held during Session #2. This second part of the program covers bribery and extortion, misuse of authority for private benefit, limitations on mass mailings, and prohibition on the use of public funds for political purposes. Most of the time will be spent covering the state open meetings law, the Brown Act, which controls many aspects of neighborhood council operation. The California Public Records Act also applies to neighborhood councils, and its strict deadlines for compliance will be covered. Finally, city rules on competitive bidding will be described, along with city rules for entering into contracts.

RECRUITMENT, TRAINING AND MANAGEMENT OF VOLUNTEERS (Including The Board!) - Room 1025

Moderator: Thomas Soong, EmpowerLA

Presenter: Pedro Barrientos, Volunteer Center of LA

The more connected people feel to a community, the more likely they are to volunteer their time and skills to make it better. The first part of a successful neighborhood council volunteer program, which includes Board volunteers, is the care and feeding of that connection. A shared sense of purpose is contagious. The second part is to realize that while volunteers provide their services free, they (we!) need the same careful attention as paid staff. Your recruitment should not be arbitrary. Although all are welcome, it is a selection process. Training is not going to be provided by an understaffed DONE. Each NC needs to have a real training program. Training is a right. It's also a way to incorporate volunteers as members of the family. When volunteers are on board and trained, they need to be managed like any workforce. There's a need for leadership, division of labor, responsibility for work, time and project management, and thanks and recognition. When you can recruit talent, match people with their interests and provide a cheerful working atmosphere, there is no end to what you can do.

EMPOWERING COMMUNITIES: HOW TO FIND AND ENCOURAGE PEOPLE WHO CARE - Room 1070

Presenter: Stephen Box

How do you find someone to join the neighborhood council? Could it be schools, senior centers or other community groups? This workshop will give you some first hand ideas for finding and encouraging even the busiest people to volunteer to empower their community.

CREATING COMMUNITY PARTNERSHIPS (Both Financial And Joint-Action) - Room 1035

Presenters: Sun Valley Area NC: Julie Monroy-Cantor, Treasurer; Robert Lim, Board Member; Mike O'Gara, 2nd VP

It's not in the Charter, but one of the important functions of a neighborhood council is community-building. One of the best ways to build community relationships is to work together. As a city agency, a neighborhood council is often in a great position to "pitch a tent" and invite everybody to come. Health fairs, education fairs and anti-gang collaboratives are examples of this kind of partnership. Partnering with other organizations is also a practical way to get things done that an NC can't do alone. Businesses, business organizations, elected officials, religious groups, schools, colleges, service clubs and non-profit service organizations are examples of possible partners who have funds, expertise, or volunteers. There are also many events put together by others in which NCs can participate. These are both outreach opportunities and "photo ops". This program will give you tips on how to team up with others, ways to handle funding, and events that work.

INTEGRATING WEBSITES, EMAIL AND SOCIAL MEDIA - Room 1060

Presenters: Liz Harsch, AdTeamLA; Enci Box, EmpowerLA





Prior to this, she was the Community Program Director for the Center for the Pacific Asian Family (CPAF) and the co-chair of the Asian and Pacific Islander Domestic Violence Task Force in the San Gabriel Valley. In her roles at CPAF and on the Task Force, Grayce worked to educate the Asian and Pacific Islander (API) communities about domestic violence and sexual assault and to build coalitions with domestic violence service providers, law enforcement, hospitals, and social services in order to provide effective and culturally sensitive services to API domestic violence and sexual assault survivors.
